## PRESIDENT'S COMMENTS

I hope everyone enjoyed their July 4th weekend. I spent the weekend by the water. There were Great Blue Herons and Ospreys. I saw a great fireworks show. In my case, I was in Seattle on family business. It was nice (very cool and no mosquitoes), but there is still nothing quite as nice as looking at the bay from the beach or marina in our wonderful community,

Many of you have met Randy, our security guard who is at the beach on weekends in the summer. He is now also providing our nighttime security patrols, along with our off-duty County police officer. Between the two of them, we have security nearly every night during the summer. Randy really loves our community and takes his job here very seriously. You have probably seen his flashing amber light as he makes his rounds. Be sure to say hello if you see him. If you have security concerns, he is always willing to listen and help.

Something that's always on our mind during the summer is mosquitoes. As I mentioned last month, on the community survey, 71% of the respondents were in favor of spraying for mosquitoes. Eightynine percent of the people who submitted a survey had an opinion on this question. At its last meeting, the HSIA Board voted to approve spraying by the MD Department of Agriculture, provided that residents could opt-out of having their property sprayed, if they desired. We have

applied for the spraying, but since the deadline has passed, it is most likely that we will not be sprayed this year. As I write this, Michael Cantwell from the MD Department of Agriculture, is scheduled to speak at our July 10<sup>th</sup> General Meeting. Although we may not be able to have an active spraying program this year, Mr. Cantwell has indicated that there may be some things that they can do to help us this season. In this issue of the Sea Breeze, there is additional information on the spraying program and a form for opting out. One thing to note is that if too many people out-out, spraying may not be done at all, due to logistics problems. However, the State reserves the right to spray the entire neighborhood anyway if there is a public health danger that needs to be addressed. If you want to opt-out, then I urge you to send in your form ASAP. By the time you read this issue, the General Meeting will have already taken place. It was well publicized, so we're hoping for a good turn-out. This is an important issue for public health and for the quality of life in Hillsmere.

Another issue that people have strong opinions about is public water. In the survey, 51% of the respondents were in favor of getting public water. However, only 65% of the property owners responded to the survey. That means that only about a third of the property owners responded as being in favor of public water. The County requires more than 50% sign a petition requesting water or it cannot be done. The survey was a massive effort. The Community Survey Committee organized over 100 volunteers to conduct the survey. They went to every house and for those who did not fill out the survey, they went back two and three times and still they did not participate. We mailed surveys to all absentee owners. The survey went on for five months. At the last board meeting, the board decided that we will not request public water. The consensus was that the effort would be extremely difficult and would likely not result in more than 50% approving the petition. We would have to start all over again. The County has specific rules and forms that must be used. However, if anyone feels strongly enough about this issue, that they would like to organize a campaign to get the signatures, then the Board will lend support to the effort.

Speaking of volunteers, I am very happy to announce that Jasen Adams has volunteered to head the Zoning & Covenants Committee. This is a very important committee. The Z&C Committee investigates complaints of zoning, covenant, and/or HSIA rules violations. It attempts to resolve complaints by contacting the violator. Complaints are filed with authorities when necessary. All complaints are followed up to ensure they are resolved. Jasen's wife, Jennifer, is a member of the HSIA Board. If you would like to help Jasen by volunteering a few hours a month, please let him know.

There have been some great projects completed at the marina and beach. The pier at Beach Drive has been completely replaced along with a new boat ramp. By the time you read this, the piers at Sunset Drive will also have been replaced. This is a great improvement, both esthetically and in terms of safety. The old piers were over 35 years old and had been built with recycled telephone poles. There was a real danger of them collapsing if a boat hit them too hard. A new infrared security camera system has been installed at the sandspit and main marina. The images are saved on a DVR and can be replayed if an incident occurs. Within the next few months, the images will be available live on our web site. There are also new gates at the boat ramps and at the main marina. The main marina gate is automatic. It will open each morning and close at dark. Anyone inside when it closes will still be able to get out. Slip holders will have electronic cards that will open the gate at any time. All of the above projects were 100% paid for by Piers & Harbors funds. Although the general membership approved taking out a loan, no loans were needed. It was entirely financed from cash reserves. The marina reserve funds that were used will be completely replenished within three years,

The beach project was paid for with Special Tax money. The bulkhead and rip-rap at the east end of the beach (toward the marina) was in desperate need of repair. It was completely replaced by a new stone revetment. The stone was extended toward the beach to protect an existing wetland area. The tall invasive grasses that obscured our views of the bay were removed and new native grasses that only grow a few feet high are being planted. The new benches had to be removed during the construction. They will be replaced shortly. This was a very successful project. Thanks to Kate Penn and the Beach Committee for all their hard work to get this done.

Speaking of the beach, please keep in mind that no dogs are allowed on the beach at any time. You can walk your dog at the marina, boat ramps or on the street. The beach means the entire park, not just the sand. I have received several complaints about violations of this rule, so please be a good neighbor and keep your dog off the beach.

The hot and muggy weather continues. One of the best ways to get outside and beat the heat is to be near the water. It's always cooler there. Hang out at the beach or marina and meet some of your neighbors. Always remember the sun screen too. Another way to cool off and have fun is to attend one of our great summer events. There will be a Beach Happy Hour on August 1st and our Ice Cream Social on August 8th. Check this issue for details. You live in a wonderful community, so get out and enjoy it!



## From the Beach Committee

## ~Kate Penn, Beach Chair

Shoreline Design has completed the construction phase of their work at the east point of the beach. At the end of July, they will install native plants to recreate the marsh that was removed as part of the construction. Spartina Alterniflora will be planted at the low area, which is primarily under water, except during low tide; Spartina Patens will be planted on the upper sections of the slope, which is wet during the high tides. The area that was previously lawn will be restored to lawn. Please be careful not to disturb the new grasses, seed, and straw netting that have been placed in the disturbed areas, so that they have a chance to take root. Although extensive sections of the Phragmites have been removed, it is likely that new shoots will appear in the improved marsh. Because the roots emit an herbicide that can damage other plants, we will be observing the area and removing new shoots.

While the Beach Committee gathers data on our shoreline conditions to plan any further work, we are also looking at ways to improve the upland areas. Runoff from several recent, harsh rain storms has carved away large sections of the sandy beach as well as the drainage area by the little bridge. We are exploring methods to better control the storm water as it runs to the bay. The improvements will filter the water, slow the flow to reduce erosion, and also reduce standing water in the park areas.

HSIA has contracted The South River Federation to provide weekly reports on the bacteria levels on our beach. In previous years, the SRF took regular samples all along the River and provided the data on their website. This year, they have agreed to sample water specifically targeting the community beaches on the South River, and to provide immediate results so we can notify residents of poor water conditions. The water is tested for enterococci, which are bacteria that come from the intestine of all warm-blooded animals. EPA states that bacteria levels higher than 158 probable colonies per milliliter (pc/ml) of water is unsafe for swimming, and young children and elderly should avoid water contact. In addition, the Health Department recommends staying out of the water for 48 hours after a heavy rain, due to rainwater runoff and increased health risks. In general, it is recommended to wash with soap and water after exposure to any natural body of water. The results from the SRF testing to date have been low, indicating the water has been safe for swimming. We will continue to monitor conditions and post alerts any time the levels rise near or above safe levels.

- The gate to the beach is opened each morning by volunteers. This year's budget includes an automatic
  opener, like the one at the marina, which will relieve our long-standing volunteers from this task.
  However, in the meantime, we are looking for people who use or pass by the beach in the morning, who
  are willing to unlock it. With enough volunteers, we can set up an alternating schedule, so no one
  person is burdened every day.
- We need new committee members to help with the maintenance of and improvements to playground and park equipment. You would help inspect equipment, make recommendations for repairs and replacements, and help with the completion of those projects.
- We are looking for teams to pick up trash, rake the beaches, wipe down the tables and benches, and sweep the pavilions. This is also a task that can be completed on a rotating schedule. Ideally, each volunteer could work once every couple months.
- Volunteers are needed to help with spotting and removing new Phragmites shoots using approved methods for treatment.

An HSIA Building Permit is required: Every time an Anne Arundel County Building Permit is required. The responsibility of obtaining an HSIA Building Permit does not fall on your builder, it falls on you.

The following items are needed to obtain an HSIA Building Permit:

- 1. A copy of the Anne Arundel County Building Permit.
- 2. A copy of the construction location on the property when required by the County.
- Cash or check in the amount of \$5.00 made payable to HSIA, unless we sent you a certified letter. Then the cost is \$20 for the permit.
- 4. Mail to HSIA, P.O. Box 3485, Annapolis, MD 21403



Permits are required for construction of new houses, new sheds, additions to houses or sheds, retaining walls, piers and bulkheads. When in doubt, or if you have any questions, please call the HSIA Building Permit Chairperson, Bill Anderson, at 410-279-1666.

#### STANDARD MOSQUITO CONTROL OPERATING PROCEDURES

The Anne Arundel County & City of Annapolis Mosquito Control Program is conducted by the Mosquito Control Section of the Maryland Department of Agriculture, located in Annapolis, under cooperative agreement with the County and City Governments.

The following services will be conducted in the indicated time frames:

County-wide Surveillance and Control of Larval Mosquitoes:

March - October

Surveillance and Control of Adult Mosquitoes: County wide Mid-May - September 25:

## OPERATING PROCEDURES FOR SPRAYING OF ADULTICIDES/LARVICIDES

Spraying for adult mosquitoes will be done only if a Maryland Department of Agriculture Inspector determines it is necessary.

Nuisance Abatement Thresholds for Ground Based ULV Treatments:

Landing Counts:

3 mosquitoes in a 2 minute count

Light Trap Collections:

12 female mosquitoes in an unbailed light trap 24 female mosquiloes in a bailed light trap

#### SPRAY SCHEDULE FOR LARVICIDES/ADULTICIDES

Larvicides (Treatment for mosquito larvae) Monday - Friday



#### MOSQUITO CONTROL POLICY STATEMENT

#### OBJECTION TO ADULT MOSQUITO CONTROL

The policy of the Maryland Department of Agriculture regarding an objection to adult mosquito control by truckmounted ultra low volume (ULV) application of insecticide is as follows:

- An individual may have his/her owned or leased real property and a surrounding buffer up to 300 feet on all sides of the property excluded from ground based ULV adult mosquito control.
- Each individual requesting this exclusion must submit the request in writing to the Maryland Department
  of Agriculture and provide copies to the appropriate community association or city/town. The request
  must provide the address of the property to be excluded and must be signed by the owner(s) or leasee(s).
  This request will be acknowledged in writing by the Department.
- If the number of individual objectors, and the location of excluded properties, precludes an effective
  mosquito control adulticide service in a community, the service in that community will be suspended.
  Service may be reinstated upon the written request of the community and approval by the Department.
- A city/town government or community association may request the Department rescind or modify a spray
  exclusion zone if the local authority believes the exemption unfairly impacts other residents who desire
  adult mosquito control service. Requests must be made in writing and delivered to the Secretary of
  Agriculture
- The Department periodically will verify the continued occupancy/ownership by objectors of properties excluded from ULV ground spraying to determine if the objection continues.
- In the event of mosquito-borne disease or conditions that threaten public health, the suspension of
  mosquito adulticide service in an area due to objectors will be discontinued and the full range of mosquito
  control procedures available will be utilized.

#### PUBLIC INFORMATION NOTICE:

Your request for exemption from adult mosquito control services by the Maryland Department of Agriculture WILL NOT be processed unless ALL of the information requested has been supplied. You have a right to inspect, amend, or correct this information. Under State Government Article, 10-617, Annotated Code of Maryland, this information may be generally available for public inspection. This information is not routinely shared with state, federal or local government agencies.




