# President's Message

### **Towing of Vehicles**

At the General Meeting on July 11<sup>th</sup> two motions were introduced to recommend to the Board of Directors that we resume towing vehicles illegally parked on Community property. Both motions, for the beach and for the marina, were passed by a 46 to 1 vote. The Board of Directors will be considering both motions at the July 25<sup>th</sup> Board Meeting. Please attend the meeting and be a part of the discussion and decision on this important issue. Information about the Board and General Meetings, and copies of motions, are on pages 6 and 7.

#### The 7<sup>th</sup> of July

Despite threatening skies, a rainbow appeared over the South River, and Hillsmere celebrated the Fourth of July three days late. Several hundred residents came out to our beach to enjoy ice cream and cupcakes, and view Edgewater's last fireworks display of the holiday. This year the show was less spectacular than usual, since the displays from across the South River were spread over a four day period. Hillsmere has no fireworks of its own, but the displays of our neighbors to the south are readily seen from our beach. Given the number of participants, we are considering making this an annual event at our Community Beach. If you enjoyed having the beach open for viewing the fireworks and would like to have the beach open next year, hopefully on the 4<sup>th</sup> rather than 7<sup>th</sup>, please email us at <a href="mailto:entertainment@hillsmereshore.net">entertainment@hillsmereshore.net</a>. I want to thank the members of HSIA for sponsoring and funding the event, and all of the volunteers who made this event possible.

## **No Soliciting**

Over the last few years there have been numerous complaints about solicitors in our community and the possibility that some may have been involved in some of the thefts that have taken place in Hillsmere. We cannot post an enforceable "No Soliciting" sign at the entrance to the community because the streets in Hillsmere are public and are maintained by Anne Arundel County. This means that we cannot restrict who may enter the community. However, the police can and will enforce "No Soliciting" signs posted by residents on their property. If you have posted your property and a solicitor walks on your yard or knocks, then police can enforce your right to remove unwanted individuals from your property.

HSIA has purchased "No Soliciting" signs that easily attach to most wood mailbox posts. We encourage you to purchase and install one of these signs. Police experience has shown that if enough residents install "No Soliciting" signs, and call the police if someone ignores the warning, solicitation in the community will be either significantly reduced or eliminated. Signs are available for \$20.00 each, and will initially be available beginning July 27<sup>th</sup>, 9 a.m. to 11 a.m. on Saturdays at the Community Beach Parking Lot and at the Community Pool. Payment should be made by check only, payable to *HSIA*. Please participate in this program and help make Hillsmere a safer and more secure community. #### **Entertainment Committee**



## Regular Meeting of the HSIA Board of Directors, June 27, 2014 Meeting Summary

The following motions were approved by a majority of the Directors present:

**Shoreline Remediation Project approvals:** Presented by Kate Penn, Beach Chair

Motion 1: The Board authorizes the President to execute a contract with Shoreline Design, LLC for phase 1 of the complete shoreline remediation project, excluding the seawall. This includes mobilization, timber bulkhead replacement, stone revetment installation, central tidal marsh enhancement and swale plantings, and timber footbridge. The President is also authorized to mediate the particular details of the contract and general conditions. Moved by Nancy Fulton; 2<sup>nd</sup> by Kathy McFadden; Vote taken: 6 in favor; 1 against

**Motion 2:** The Board hereby allocates up to \$77,000 of FY2013 Property Improvement Special Tax funds for the first phase of the shoreline remediation project. **Moved by Nancy Fulton; 2<sup>nd</sup> by Kathy McFadden; Vote taken: Unanimous approval.** 

**Project Approvals:** Presented by Christian Elkington, Property Management Chair

Motion 1: Pet Waste Stations: The board approves up to \$2,500 to purchase 5 pet waste stations to be located as noted; Kate and Christian will determine the exact location of the station at the beach. Moved by Kathy McFadden; 2<sup>nd</sup> by Shannon Frece; Vote taken: 6 in favor; 1 abstain.

Motion 2: Pool Park repairs – To repair the damage from the car/vandal at the park area by the pool: the board approves permit funding, not to exceed \$2,200, and repair funds not to exceed \$2,500. Moved by Nancy Fulton; 2<sup>nd</sup> by Helene Raven. Vote taken: 5 in favor; 1 against; 1 abstain.

Motion 3: Pool Security Camera – To add outward-facing cameras to the current security system: The board authorizes up to \$3,500 to purchase and install 5 security cameras and an additional DVR pending confirmation that the cameras will achieve the desired coverage. Moved by Helene Raven; 2<sup>nd</sup>by Nancy Fulton; Vote taken: Unanimous. Note: TJ Hurlburt offered to review the scope of coverage and placement of camera with the proposed system and present at the next meeting.





# General Meeting of the HSIA Membership, July 11<sup>th</sup>, 2013 Meeting Summary

#### There was a quorum of members at the meeting.

**Changes to the Board:** Christian Elkington mentioned that Nancy Fulton will be leaving our community. Christian thanked Nancy for all she has done as Treasurer.

#### The following motions were approved by a majority of the Membership present.

**Motion 1:** Move that HSIA resume towing vehicles at the Community Marina that do not display a HSIA Parking Sticker or a Marina Guest Pass. Towing shall be resumed on a date specified by the HSIA Board of Directors with prior notice to the Community. All vehicles identified for towing shall have the concurrence of the Chair, Security Committee, and one of the following Chair, Piers and Harbors, President HSIA, or Vice President HSIA. If the Chair, Security Committee is unavailable, towing shall require the concurrence of a minimum of two of the designees. The Board of Directors, Chair, Security Committee and Chair, Piers and Harbors Committee shall implement appropriate measures to minimize the risk of towing of resident vehicles.

This motion shall require the concurrence of the Board of Directors prior to implementation. Moved by T.J. Hurlburt, 2<sup>nd</sup> by Steve Vanderbosch; Vote taken (including proxies): 42 in favor; 4 opposed.

Motion2: Move that HSIA resume towing vehicles at the Community Beach that do not display a HSIA Parking or are not vehicles of guests accompanied by a resident. Towing shall be resumed on a date specified by the HSIA Board of Directors with prior notice to the Community. All vehicles identified for towing shall have the concurrence of the Chair, Security Committee, and one of the following Chair, Beach Committee, President HSIA, or Vice President HSIA. If the Chair, Security Committee is unavailable, towing shall require the concurrence of a minimum of two of the designees. The Board of Directors, Chair, Security Committee and Chair, Beach Committee shall implement appropriate measures to minimize the risk of towing of resident vehicles.

This motion shall require the concurrence of the Board of Directors prior to implementation. Moved by T.J. Hurlburt, 2<sup>nd</sup> by Kathy McFadden; Vote taken (including proxies): 46 in favor; 1 opposed

In accordance with the new procedures adopted by the HSIA Board of Directors, both of these motions will be taken into consideration at the next Board Meeting, on July 25<sup>th</sup>.



# **Piers & Harbor News**

#### **Current Events**

I hope everyone is enjoying the new dock. While the contractor work on this project is complete, the Construction committee continues compiling all the information we learned about our facility, including several hundred photos that document the project. The Slips committee has filled all slips and is reducing the vacancy rate, currently at about 15% (A vacancy is a paid slip, but the holder has been unable to place a boat in the slip). There are currently 21 people on the wait list. The Steering committee has drafted a new "Slip Permit," which plugs a couple of holes uncovered during the reconstruction project. This

document needs HSIA Board approval before being officially issued. I expect this process to

renumbering after the reconstruction, electrical panel documentation, piling bumpers, etc.

The Operations committee has an on-going list of projects: Slip

take several months.

# In the recent past, Blue Guard security has written several hundred citations to drivers with a car on the dock without a HSIA sticker or guest passes. However, it appears the repeat offenders aren't getting the message. Towing these cars has been discussed at the P&H level, and at General and Board meetings, and has been, with little exception, supported and encouraged at all levels. This issue will be discussed again at the July Board meeting, and will likely conclude with a vote to initiate towing. If so, expect towing to begin at the main dock sometime in August. I also expect a prodigious PR campaign to alert the general Hillsmere population of this program. Please "stay tuned" for more information on this subject.

# **Security Cameras**

With the completion of the dock reconstruction project, all three security cameras are fully functional. These cameras are day/night (IR/low light) cameras and record 24-hours a day.

# Crabbing at the main dock

The is summer in full swing, and the crabbing activity at the main dock has returned. This is a reminder to all who participate in this Chesapeake Bay tradition that there are some guidelines and laws regulating crabbing at the Hillsmere main dock.

- Please clean up after yourself and carry out as much as you can so as not to load the trashcans with raw meat that attracts rats and other vermin.
- Please do not remove any nails from the copper flashing atop the pilings. This allows the sharp copper edges to protrude, which is a health risk if you or someone else gets cut.
- Please be courteous to others who are using the dock keep your gear such that others can easily pass by.
- Per Maryland state law, crab pots may only be used on privately owned docks. The main dock is owned by HSIA and is not *your* private dock therefore no crab pots may be used on the main dock. Crab pots found in use will be removed without notice.
- Per Maryland state law, night-time crabbing is not permitted.

#### **Channel Markers**

If you have not noticed, HSIA has 7 channel markers that are privately maintained, approved and on the USCG Light List. Unfortunately, these markers were not installed with appropriate ground tackle and have moved since they were placed after the dredging project. In the coming months look for these markers to be removed for maintenance and relocated when they are re-deployed. This is a coordinated movement with the USCG and DNR so that we don't jeopardize our permit to have the markers.

Many of the boaters in our community have been here for years or decades and may find these markers unnecessary. However, as a relatively new resident of Hillsmere I, for one, don't have the local knowledge some others have in the marina. These markers are intended for boaters, like me, with less familiarity of our waters.

#### **Boat Park**

In the April 2012 Sea Breeze I mentioned that the Grand Father Clause for storage of articles other than boats will be terminated at the end of the 2012 season. With the new Boat Park rules in place, we require all non-boat related trailers and other articles to be removed from the Boat Park. Additionally all vessels and trailer show a current registration. Please do not hesitate to move these items out before we call you. Your cooperation is much appreciated.

Lastly, a rate increase is being evaluated for the Boat Park spaces. Currently, we pay more for maintenance than the Park takes in for fees. I expect the increase to go into effect next season.


#### New Committee Volunteers Needed

# Hillsmere Emergency Assistance Team

# "People caring for people"

As most of you know if you have lived in Hillsmere for more than a couple of years, we periodically face power outages, wind storms, heavy rain, flooding, trees and wires down, to name a few community problems. To help our Hillsmere neighbors, who may face problems as the result of these situations, we are building a network within Hillsmere whose goal is to be prepared for these and other types of emergencies.

As we also know from past experience, our local government cannot always come to residents' aid as quickly as we would all like to see. When these emergencies happen in Hillsmere, it is probably occurring all around us—think Isabel and last year's Derecho.

The purpose of the Hillsmere Emergency Assistance Team (HEAT) is to be the community resource that makes Hillsmere <u>self-reliant</u> in such emergencies. HEAT teams will remove downed trees blocking access and egress. HEAT teams will have the capability to meet other emergencies—looking for a missing child, a child that didn't get off a school bus or an elderly person who may have strayed from home. HEAT teams will assist sick or elderly persons housebound in bad weather. In some of these cases, minutes count.

As a part of HEAT, we would like to include a capability to be able to make minor\_home repairs for some of our neighbors (single parents, elderly residents, the disabled, etc.) where these repairs may be beyond their skills or capability.

To establish HEAT, we want to engage three types of volunteers:

- COORDINATORS willing to spend time getting to know their immediate neighbors to become familiar with any special needs who may require assistance in an emergency
- RESPONDERS willing to help with ideas, skills and tools (e.g., chain saws) to serve on HEAT response teams in an emergency
- HELPERS, a few community-spirited individuals willing to volunteer their time, skills and tools to help some of our Hillsmere neighbors in need of minor home repairs



# **Security**

I hope everyone is having a great summer. Hillsmere is a gem of a community for warm weather activities. The beach, marina and pool are wonderful ways to spend time with family and friends.

To get started on this month's report I would like to bring up the issue of dogs at the beach and marina. I have mentioned this numerous times in my report, but unfortunately last month a child was bitten at the beach. The child would have never been bitten if community rules were followed. At the beach, pets are not permitted at all, that means never – no excuses. Pets are welcome at the marina, but please remember to pick up after your pet; and remember they must be on a leash – it's a county law.

We are still experiencing trespassing at the beach and marina by non-residents. So please be advised you will be stopped if you do not display a 2013 community sticker on your vehicle. Vehicles not displaying current stickers are subject to towing, booting, trespassing charges and ticketing. Slip holders remember to get 2013 guest passes, as your guests vehicles are subject to the above. Stickers and hanging tags help the police and guards distinguish residents from non-residents. Additionally, we have had numerous non-residents parking outside the marina and beach trying to gain access. If you see this behavior, as a resident you can call the police or security to report trespassing on your community property. Remember it is your community property, not all of Annapolis's.

Are you tired of unwanted solicitors at your door? Hillsmere has invested in uniform signage for you to post on your property. The signs are \$20 each. You can purchase the signs starting July  $27^{th}$ , on Saturdays at the beach or pool from 9-11 a.m. Payment must be in the form of a check payable to HSIA.

Remember – the security committee offers special patrols while you're on vacation, monitors problem areas, school bus stops and community property. Contact security at security@hillsmereshores.net with any special needs.

#### REMEMBER PETS ARE NOT PERMITTED AT THE BEACH!

We had a recent incident of a child bitten by a dog at the beach. This situation would have been avoided if the pet's owner had followed our rules. This is an important rule and is in effect for obvious reasons. Please respect your neighbors and your pets and follow the rules.

**Shoreline Remediation Project:** The board has approved a contract for Shoreline Design to complete the shoreline improvements at the beach. Shoreline Design was selected in a closed, competitive bid. Shoreline Design installed the stone revetment at the east end of the beach park, and restored the marsh alongside the revetment. Details about the bidding phase are available on the web at www.hillsmereshores.net.

The permits for the project are still in review by Anne Arundel County. We had some delays do to the large overall area of work in the buffer zone. We anticipate comments or approval at the end of the month. If we successfully receive approvals, the project will begin at the beginning of August. If the reviewer has comments that require further alterations, the project may be delayed to later in the month.

Please note that East end of the park will be closed to all recreational activities during construction. The east end of the parking lot (the paved section), the tot lot, both the east and central/west points, and the swim area at the concrete seawall will be closed during construction. This is for your safety, and we ask parents to help reinforce this rule with their children. Also, because of the repairs to the bulkhead we will need to dismantle the old boat and double swing at the central/west point. When construction is completed we will install a new, yet to be determined, structure in its place. Let us know what you'd like to see there! Email beach@hillsmereshores.net with your suggestions.

**Operation Clean Water, Summer 2013:** The South River Federation (SRF) provides weekly testing of the microbial water quality for communities on the South River. The water sampling counts the levels of fecal contamination in the water, and helps us gauge how safe the water is for swimming. If the levels exceed 104 cfu/100 ml, the water is not safe for swimming.
