The signs must be no great than 2 by 3 feet or equivalent area. Political signs may not be placed on HSIA property.

Motions from the September Board of Directors Meeting:

POOL:

Brooke George moved the Board approve the recommended changes to the Black Walnut Cove agreement, along with the price increases. Ray Sullivan seconded the motion. Vote taken – unanimously approved.

BEACH:

Brooke George moved the Board approve NTE \$2000 for Carl Corse to conduct a site analysis and prepare a construction plan for the drainage area at the beach. Lori Nichols Hogbin seconded the motion. Vote taken – unanimously approved.

PIERS & HARBOR:

- Steve Vanderbosch moved the Board rescind its prior action in naming the Marina “The Bill Anderson Hillsmere Shores Community Marina” and moves the Board dedicate the Marina to Bill Anderson for 46 years of service to the community, with a dedication ceremony to be held at the community pig roast; and the Board approves the expenditure of \$350 for the fabrication and installation of a sign to be added to the Marina sign reading: “Dedicated to Bill Anderson for 46 Years of Service to the Community”. Ray Sullivan seconded the motion. Vote taken – unanimously approved.
- Steve Vanderbosch moved the Board approve the expenditure of P&H funds NTE \$2,500 for plumbing repairs and improvements at the Marina, to include replacing rusted and broken faucets and handles, and the installation of additional cut-off valves in the fresh water system. Kathy McFadden seconded the motion. Vote taken – unanimously approved.

Mike Penn - Candidate for President

I have been a Hillsmere resident since 2004. My wife Kate and I have 3 children who attend Hillsmere Elementary and Annapolis Middle Schools. We also have a cat, a dog, two fish, and a hamster, none of whom attend school.

I served as an HSIA board member for a year before running for President. I ran because I felt the negativity and contention at our board and general meetings kept the board from providing the neighborhood with the governance and support it really deserved. While I ran uncontested in the last election, my goal was to empower volunteers and encourage more participation. We needed leadership that would stand in front, without getting in the way, of our volunteers. The last board election had more candidates than usual; our current board has productive meetings, and new people are stepping up to volunteer.

For the last two years I have encouraged committee chairs to make and implement decisions at a committee level. While the board remains involved in committee activities, the directors have come to trust the chairs and to respect their opinions.

My approach to helping volunteers achieve what they want, as opposed to telling them what to do, has led to an upswing in the number and variety of people taking part in the neighborhood. If you like this direction of the community, I ask that you not only re-elect me, but also vote for our current Vice President, Jerry Lichtenberg; our current treasurer, Gene Gross; and our Secretary of choice, Lori Hogbin. We have worked well as a team, and would like a chance to continue to serve the neighborhood.

Ray Sullivan - Candidate for President

Since moving to Hillsmere in 2001, my wife and I have grown to love this community. Hillsmere has a rich history, with established families that have lived here for generations. Over the last several years, we have seen many young couples moving in, largely because this is such a family friendly community.

Serving on the board for over ten years, I am currently the longest serving board member. As President, I hope to use my experience to maintain a balanced and inclusive atmosphere within the community, and continue to strive for what's best for Hillsmere. Topics such as the community center, pool, beach, and storm water management, need to be discussed in such a way that all sides are heard, in order to come up with balanced and economical solutions.

I have a positive vision for the future of our community. I would like us to be thinking of a long range view of the future of our community, including exploring our options to create a community entrance to Quiet Waters Park.

HSIA Election Voting Instructions

Vote By Mail: If you are unable to attend the November 10th HSIA General Meeting, follow these simple steps in order to vote by mail.





1. Tear the ballot out of the Sea Breeze or download a copy from the web site.
2. Fill out the election ballot.
3. You **must** include your name, address, date, and signature in the space provided on the ballot.
4. Mail the signed ballot to **HSIA, PO Box 3485, Annapolis, MD 21403**. Be sure to mark "Ballot" on the envelope.
5. Ballots must be received prior to the General Meeting.

Vote In Person: Please note: If you are voting in person, there is no need to provide your name, address, date, and signature on the ballot.

1. Tear the ballot out of the Sea Breeze, download a copy from the web site, or pick up a ballot at the meeting.
2. Have your ballot validated upon arrival at the meeting. You do **NOT** need to mark your selections before the ballot is validated.
3. Please be prepared to show a picture ID.
4. Drop ballots in the ballot box or hold them for collection.

Note: You may have someone else drop off your completed, signed ballot at the General Meeting by following steps 1, 2, and 3 in the **Vote by Mail** section above.

The Boating Season Is Winding Down

The summer boating season is winding down, and we hope that everyone has enjoyed the great weather this year and been able to get out on their boats, canoes and kayaks. Let's hope good, storm-free weather continues through the winter!

Winter Preparations

Soon enough, colder weather will arrive, and the Hillsmere Marina facilities will transition to winter operation. That means: (1) the water at the main Marina will be turned off as soon as we get a freeze, hopefully not until mid-November, but maybe as early as Halloween; (2) we will try to accommodate slip holders who are leaving their boats in the water with temporary assignment to more protected, Winter Slips; (3) all boats staying in the water over the winter need to be properly secured, with extra lines as necessary, for the normally rougher winter weather; and (4) ice-eaters will be installed throughout the Marina to prevent ice buildup.

Winter Slips

All slip holders are requested to notify the Slips Committee about plans for your boats this fall/winter. This will help us determine ice-eater locations, and make some bulkhead slips available to A and C Dock slip holders remaining in the Marina for the winter. If you will be removing your boat for the off-season, please email your intentions to the Slips Committee at mari-naslips@hillsmershores.net. Please include your name, slip number, approximate date out and ap-

For A Dock and C Dock slip holders who plan on remaining in the Marina for the winter, you may request a bulkhead Winter Slip by emailing the Slips Committee at marinaslips@hillsmereshores.net. If you are a current bulkhead slip holder and will remain in the Marina, you need not do anything. You will keep your slip as assigned.

Winter Slip assignments are temporary, and *Winter Slips must be vacated by March 15, 2017*, or sooner if requested by the permanent slip holder. Failure to remove your boat from a temporary Winter Slip assignment may result in transient charges of \$1/foot/day.

P&H Meeting Time and Place

The P&H monthly meetings are normally held on the second Tuesday of each month at 7 p.m. in the Key School Science & Library Center (the building closest to Carroll Drive), Room 102. All slip holders, ramp key holders, Wait Listers, Kayakers, Boat Parkers, etc. are encouraged to attend. As an all-volunteer organization, we welcome your ideas and your participation. Volunteers are always needed for various sub-committees, such as Operations and Slips. Hope to see you there!

Community Center Update

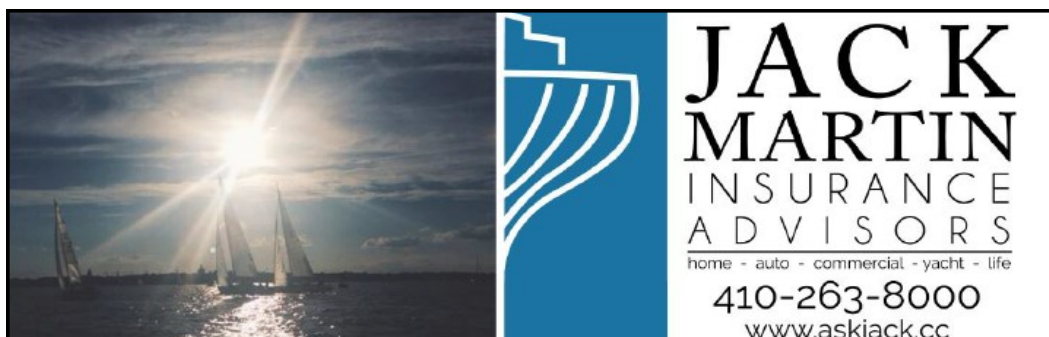


There was a Special Meeting of the HSIA Board on October 10 that was open to the community to discuss the proposed redevelopment of the Hillsmere Community Center (the White House on the corner of Harbor Drive and Great Lake, north of the pool), as well as other possible locations within the open area next to the pool.

The topics discussed were the results of the community survey that was sent out to all HSIA property owners in May 2016, and included proposed funding for the project, initial recommendations by the Hillsmere Community Center Committee (HCCC) on Architecture and Engineering design firms for Board consideration and possible selection to move forward with advanced planning and design. Survey results determined that of the Hillsmere residents who provided responses, a majority have a positive interest for the community center and the possible benefits that it would provide as a forum for community, social, official meeting gatherings and other proposed activities. Proposed programming would be geared for all interested residents, including all ages.

As for funding, a number of ideas were discussed including raising special taxes, seeking tax-exempt status and reworking the HSIA budget in order to free up additional funds from other line items. Finally, with over 1,200 homes in Hillsmere, the HCCC proposed a Community Center that would be about 3,000 square feet above grade, as well as a lower below grade walk out level. A goal of a proposed facility design would be to accommodate a large HSIA member gathering for neighborhood social functions, regular Board Meetings, other HSIA meetings, a venue where birthday or other special parties could be hosted by residents and a forum to hold a variety of exercise classes, instructional programs and neighborhood clubs to provide more amenities within and for the HSIA community. Another goal is to provide further opportunities to bring HSIA members together on a year-round basis, further enhancing the strong community bonds which characterize the wonderful community we have and share.

The HSIA Board asked the HCCC to present both smaller and larger options, as well as other associated construction costs at the next HSIA Board Meeting which is always the last Thursday of the month. We welcome hearing your ideas on the kind of classes, activities, clubs and functions that a redeveloped Community Center would offer, subject to additional phases of the planning process, design proposal evaluations, Board approval and affirmative HSIA vote once various studies and preliminary planning has been completed by retained design professionals. Update on Community Based Project to Address Pet Overpopulation

The Hillsmere community cat project initiated by Anne Arundel County is well underway. We had a well-attended kick-off at Key School on October 8th to inform residents about the purpose and benefits of the program. If you missed the kick-off and you're just hearing about this exciting FREE program, here's what you need to know:

* HILLSMERE was selected for the program because more cats have been turned into animal control from Hillsmere than from any other community in the county.

* TO DATE 28 cats have been spayed or neutered. Three of these cats are friendly, adoptable cats that are available for adoption.

* ALL CATS in Hillsmere (indoor, outdoor, owned or homeless) are available for FREE spay or neuter. The cats will also be vaccinated and given a microchip.

* PLEASE be the eyes and ears for this program by reporting any sightings of apparently homeless cats. BUILDING PERMITS – Who needs one?

An HSIA Building Permit is required: Every time an Anne Arundel County Building Permit is required. The responsibility of obtaining an HSIA Building Permit does not fall on your builder, it falls on you.

The following items are needed to obtain an HSIA Building Permit:

1. A copy of the Anne Arundel County Building Permit.
2. A copy of the construction location on the property when required by the County.
3. Cash or check in the amount of \$5.00 made payable to HSIA, unless we sent you a certified letter. If a Certified Letter is required, the cost is \$20 for the permit.
4. Mail to HSIA, P.O. Box 3485, Annapolis, MD 21403

Permits are required for construction of new houses, new sheds, additions to houses or sheds, retaining walls, piers and bulkheads. When in doubt, or if you have any questions, please call Carl Corse, HSIA Building Permit Chairperson, at 410-263-4456.
