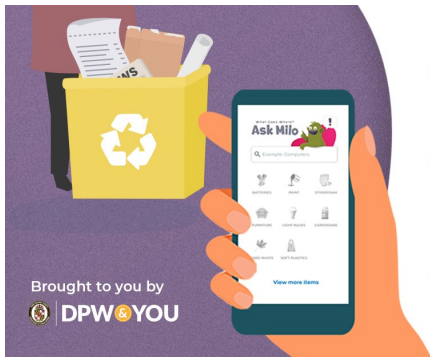

Motions from October 2021 Zoom Board meeting:

TREASURER'S REPORT:

- Gene Gross moved the Board approve the General Fund budget for the Fiscal Year 2023 in the amount of \$40,000. Ray Sullivan seconded the motion. Vote taken – unanimously approved.
- Gene Gross moved the Board approve the Piers & Harbor budget as submitted by the Piers & Harbor Committee for the Fiscal Year 2023 in the amount of \$156,000. Steve Vanderbosch seconded the motion. Amended motion – Gene Gross moved the Board approve the Piers & Harbor budget as submitted by the Piers & Harbor Committee for the Fiscal Year 2023 in the amount of \$156,000 to include fee changes put forth by the Piers & Harbor Committee. Phil Jones seconded the amended motion. Vote taken – unanimously approved.
- Gene Gross moved the Board approve Teresa Sutherland for the position of Assistant Treasurer. Steve Vanderbosch seconded the motion. Vote taken – unanimously approved.

PRESIDENT'S REPORT: Mike Wurst moved the Board approve \$1500 for Isabelle DeLaCruz Cleaning Service for cleaning of the pool for the 2021 season, 15 dates. Maureen Sherer seconded the motion. Vote taken – unanimously approved.

PIERS & HARBOR:

1. Steve Vanderbosch moved the Board approve the expenditure of funds NTE \$3,500 to Bastion Security for the purchase of a set of new locks for use at the Ramps and/or Marina, the annual re-keying of lock cylinders for locks at the ramps and the boat park, and the annual purchase, cutting and stamping of 320 restricted keyway (Do Not Duplicate) keys for the boat/kayak ramps and the boat park. Mike Wurst seconded the motion. Vote taken – unanimously approved.
2. Steve Vanderbosch moved the Board approve the expenditure of up to \$1,000 for plumbing services by Heidler Plumbing for winterizing the Marina Water System. Gene Gross seconded the motion. Vote taken – unanimously approved.
3. Steve Vanderbosch moved the Board:
 - In connection with the Sand Spit Living Shoreline project and the application by the Arundel Rivers Federation to the Watershed Assistance Grant Program for project design funding, the HSIA Board authorizes the offer of HSIA matching funds in the amount of \$10,000 or such lesser amount as may be determined by the HSIA President.
 - The HSIA Board confirms that as part of a Memorandum of Understanding typically entered into with the County and the Federation for such projects once they are funded, HSIA agrees to assume responsibility for maintaining the Sand Spit Living Shoreline project in perpetuity. Phil Jones seconded the motion. Vote taken – 7 in favor (Maureen Sherer, Gene Gross, Steve Vanderbosch, Jay Harper, Ray Sullivan, Claire Corcoran, Mike Wurst); 1 opposed (Phil Jones); motion passed.

BEACH: Maureen Sherer moved the Board approve \$398 for the purchase of a Book Exchange box kit and required associated supplies. Mike Wurst seconded the motion. Vote taken – unanimously approved.

Watershed Steward News

Trees give us oxygen. Trees slow and absorb stormwater and hold soil in place. Trees fight climate change by sequestering carbon. They provide habitat and food for birds and insects and they are beautiful throughout the year. Imagine more trees filling our yards and public spaces providing such benefits. Last October, three Watershed Stewards and eight Hillsmere volunteers worked toward such a goal at the boat ramp at 609 Beach Dr.

The Watershed Seward Academy (WSA) trains stewards to bring awareness to managing stormwater that flows from our yards and public places into our local waterways. The stewards share with the community the latest methods. In addition, because Anne Arundel County has lost so much tree canopy in recent years, the Tree Trooper program was formed. With the help of the WSA and the Tree Trooper program, the boat ramp on Beach Dr. received twenty new native trees.

Storm water runs directly into Duval Creek from the two grassy swales alongside the wide driveway. The trees volunteers planted will slow and absorb that stormwater. They are native trees, meaning they evolved in our climate and soil and with our native bird and insect species. They won't need extensive care. They are resilient and can tolerate both drought or wet conditions. The trees that were planted will not become so large that they will interfere with power lines or vehicles using the boat ramp.

Hillsmere volunteers arrived on both planting days on foot and on bicycle to further minimize environmental impact. Some even strapped and secured their shovels and tools onto their bikes! Individual action makes a difference, if it be either planting trees or leaving the car at home. He told us the pandemic offered him time to expand his passion for this delicious, useful activity. He gave us hints about how to prepare acorns and identify good hickory nuts (they are BAD if they float). He sang the virtues of fiddlehead juvenile ferns, showed us images of two hefty fungi (hen of the woods and chicken of the woods) and much more. He cautioned that plants (among other things) cannot be taken from the parks and that anything treated with pesticides would not be considered edible! Before the meeting without refreshments due to COVID regulations, members and guests socialized, and “fluffed” artificial evergreen garlands for use at QWP Visitor Center during the holiday season. Though some long-time community projects are suspended again this year, the holidays are still the club’s busiest time with members participating in holiday decorations at the Library, Quiet Waters Park, and State Circle.

Members and guests will celebrate at a “Frostbite” meeting/party on December 15th at 12:30 at the Sassafras Pavilion at Quiet Waters Park. Members will receive information about the gathering in the Buzz. Non-members are welcome; however, they should plan to RSVP for “instructions” of what to bring and in case of weather-related changes or cancellation.

Beach Report

On October 29, high tides coincided with a storm which had significant winds from the east. Much sand was deposited all along the shoreline, signs of a healthy beach experiencing natural replenishment. The eastern restoration area had sand deposited upland of the roped-in area. There was sand deposited along the western shoreline across the walkway and well into the Walker Pavilion. Sand had to be shoveled from it and the walkway. Additionally, a lot of woody debris and litter washed up. Fortunately, there was no damage to any trees from the storm.

However, deer have damaged several of the young trees planted a year ago. They are now protected inside tree shelters made from chicken wire. The replacement picnic tables for the small pavilion are expected to arrive in early March.

Little birds are frequently seen flitting about in the shrubs in the eastern area recovering from the phragmites infestation. While the initial cutting of the phragmites was done professionally, the second and third follow-up cuttings were done by volunteers. The final cutting of the season will also be done by volunteers after Thanksgiving. We are following our approved Vegetation Management Plan, and this will be a multi-year effort. Some have asked why we are ignoring the phragmites in the central vegetated swale. The upkeep of the swale is contracted to a company. While we have pointed out the phragmites problem, the swale does not fall under the Beach Committee's purview.

Santa will visit the Beach on Sunday, December 5 as part of the Santa Caravan festivities. Decorated cars will meet at the Beach at 5:15 PM to follow Santa's truck. After the caravan drives through Hillsmere, there will be a short gathering at the Beach. My dear mother used to say that Santa represents the spirit of kindness to children – all children, everywhere. With this spirit in mind, if possible, please bring a canned good or unwrapped toy to donate. (Additionally, the Fire Department's Santa Run will be on December 12, but this does not involve the Beach.)

The migratory water fowl will be arriving soon to cheer us up. Sometimes we have a wonderful view of them from the Beach. Other times the Marina offers the best view, sometimes the little kayak docks at the Beach Drive locations are best. Here's hoping we have a number of mild winter days to enjoy our Hillsmere visitors.

While long-time Beach Committee member Phil Jones will continue to serve on the committee, he has been telling me that he needs to take a less active role in the care and maintenance of our Beach. Phil has been a dedicated, contributing member for many years. He has repeatedly fixed playground equipment, installed grills, installed picnic tables, replaced bench slats, installed and maintained the nautical rope fencing, among many other projects through the years. When contractors installed the replacement playground equipment last spring, Phil spent two entire days at the Beach to be a resource person. In short, he has worked tirelessly for years to maintain the Beach that we all treasure. During my year as chair, he has been an invaluable resource to me. I know I speak for our many past and present neighbors in thanking Phil for his generous service to our community.

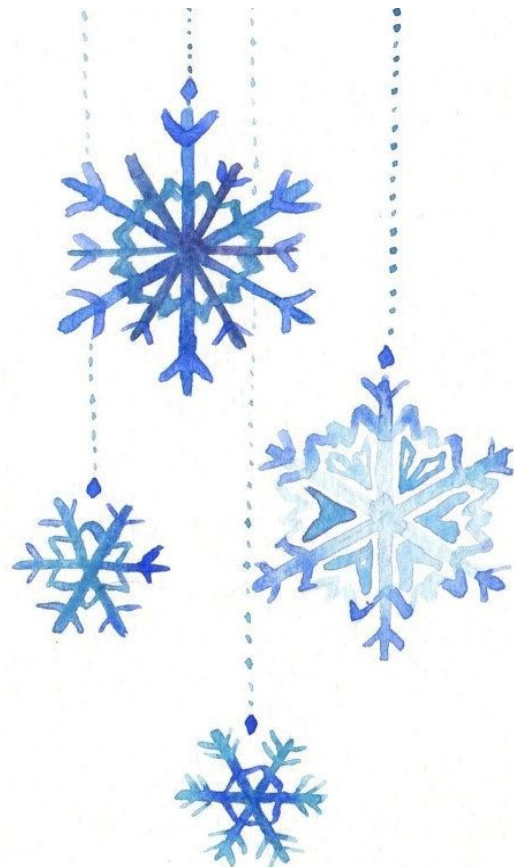

HSIA Building Permits



Are you aware that an HSIA Building Permit is required every time an Anne Arundel County Building Permit is issued for any work done at your property? The responsibility of obtaining an HSIA Building Permit falls on the owner, not the contractor.

Why does HSIA require and issue building permits? Per [HSIA Covenants & Deed Restrictions](#), HSIA's sideline setbacks (15') are different from the County (7'). We encourage anyone having work done at their property to reach out to the HSIA Building Permit Chair before designing your structure or applying to the County. Failure to obtain a HSIA Building Permit prior to the start of construction will result in a stop work order and, at a minimum, an increase in the cost of the permit.

The fee for an HSIA Building Permit is \$25. The fee increases to \$50 if work has already begun and you failed to apply for an HSIA Building Permit. **The following items are required to obtain a HSIA Building Permit:**

1. A copy of the Anne Arundel County Building Permit.*
2. A TO SCALE copy of the site plan.*
3. A copy of the plans and elevations, TO SCALE, of the structure. *
4. Cash or check in the amount of \$25., made payable to HSIA
5. Mail all required items & payment to HSIA, PO BOX 3485, Annapolis MD 21403
6. Provide current mailing address, as your HSIA Building Permit will be mailed via USPS

**AN EMAILED PDF OF THE COUNTY PERMIT AND THE TO-SCALE SITE and/or STRUCTURE PLAN IS PREFERRED AND MAY EXPEDITE THE PROCESS OF OBTAINING A HSIA BUILDING PERMIT.*

[HSIA Covenants & Deed Restrictions](#), recorded among the Land Record of Anne Arundel County, Maryland in Liber 900, Folio 334, are binding as a matter of law and are for the benefit of all other lot owners in Hillsmere.

[Anne Arundel County Code, 2005, Article 18, Zoning, Title 2, General Provisions, Subtitle 3, Setbacks](#)

For permit approval, please allow 10 working days to receive your permit in order to allow time to make sure all of your documents are legible (do not take photos of documents and email them), review it, verify your request meets HSIA Covenants and setbacks, and contact you for any questions on the submission. Please provide your current mailing address if it is different than the address on the AA County Building Permit. Your permit will also be mailed, via USPS, which takes several days.

If you have any questions on the setbacks, please see paragraph 2 on the previous page, or, feel free to ask before you go to the trouble of getting a County permit and find you cannot get an

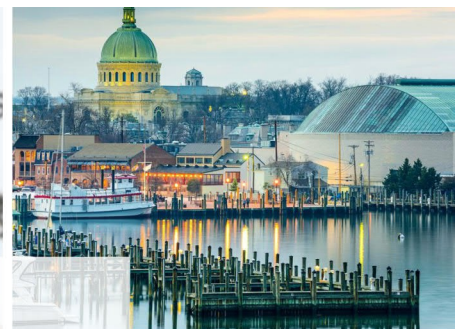

Sand Spit Living Shoreline Project

Our project partner Arundel Rivers Federation has finalized and submitted a grant application to the Department of Natural Resources Watershed Assistance Grant Program seeking grant funds for the full design of the Project. The HSIA Board of Directors has agreed to offer matching funds of \$10,000 toward the design costs.

On Sunday November 14th, at a Meet and Greet event hosted by Sharon and newly elected HSIA Board member Adam Blugis, we had the opportunity to brief the District 30A State House Delegation -- Senator Sarah Elfreth and Delegates Dana Jones and Shaneka Henson-- as well as 6th District Anne Arundel County Councilwoman Lisa Rodvien, on the Sand Spit Living Shoreline Project. All of our elected representatives were supportive of the project and expressed willingness to write letters of support for the application for design funding. The District 30A Delegation members also stated their willingness, assuming the project is designed, approved and moves forward, to sponsor a State bond bill to assist in project construction costs.

Winterization at the Marina

The Marina Water System and the Pump Out System were both shut down and winterized on Monday November 22nd. If you have a hose at your slip, please drain it and store it at home over the winter. Three hoses had to be cut during winterization because they were stuck/corroded onto the faucets.

Ice eater installation is tentatively scheduled to take place on Saturday, December 11th. An email call for volunteers will be sent out asking for help from slip holders who would be comfortable working in groups of two to install the ice eaters, which will be pre-positioned (we hope) at the slips where they will be placed to minimize time and effort required for installation.

We have had a very mild fall, and the long-range forecast is for a mild start to December. With luck, the ice eaters will not be needed at all during the winter, similar to last winter.

If you are leaving your boat in the water at the Marina this winter, please:

- Make sure your boat is properly moored, using extra lines, spring lines and chafing guards as necessary.
- Check your boat often, especially after storms, high winds, and extreme tides. (See note below about tides!)
- Do not use unattended space heaters in your boat!
- Be a good neighbor! If you see any boat at the Marina that needs attention for any reason, please send an email to marina@hillsmershores.org or call 410-212-6978 and someone will respond.

If you have hauled or will haul your boat this winter, please remove all mooring lines (and hoses, see above). Mooring lines and hoses left at vacated slips may be removed and disposed of.

Winter Slips

The Slips Committee will be offering temporary winter slip assignments, in more protected slips behind the bulkhead (Slips #1- #51), to the extent they may be available, to slip holders who are leaving their boats in the water for the winter. Contact marinaslips@hillsmereshores.org. About every fifth slip will be used for ice eaters, so fewer slips may be available for Winter Slip use.

Reminder: Winter Slip assignments are temporary, and the *Winter Slips must be vacated by March 15, 2022*, or sooner if requested by the permanent slip holder. Failure to remove your boat from a temporary Winter Slip assignment may result in transient slip charges of \$1/foot/day beginning April 1, 2022.

Flood Tide on October 29-30

The Marina and ramps experienced significant flooding on October 29th-30th, the highest tide and worst flooding since Hurricane Isabel in 2003. At the midnight high tide the entire Sand Spit and the docks were all 12 to 18 inches underwater. The lower portions (1/3) of numerous shore power pedestals were submerged. Power to the Marina and Boat Ramps was turned off on Friday, October 29th, and turned back on Monday, November 1st, after allowing time for the fixtures to dry out.

Upon re-energizing the power system, however, a short occurred in the well house, damaging both the well control unit and the well pump. It appears that when the well house flooded, a pocket of water was captured in an electrical connection between the well control unit and the well pump which did not properly drain and dry out. Allied Well Drilling was called upon and replaced the well control unit, the well pump (under warranty) and the affected wiring. It appears the long-term fix will be an above-ground addition to the well house where the well control unit and all electrical connections can be relocated.

The good news is that there was no damage to the docks or ramps or boats in the Marina. The gravel lot experienced some rutting, which may need to be addressed next Spring. At the first two black pine trees, the coir logs survived as did the grasses, but much of the soil over the tree roots was washed away and has since been replaced.

Budget, Slip Fees and Other Fees for Calendar Year 2022

The HSIA Board of Directors has approved the proposed P&H Budget for FY 2023, and approved the schedule of fees for Calendar Year 2022 as recommended by the P&H Committee. This includes modified fees for the Sunset Ramp slips, and changes to the schedule of Late Fees.

2022 Come And Get It Day (CAGID) TBD

HSIA officials are working on scheduling some form of a Come And Get It Day in February 2022. HSIA Membership renewals, Slip, Boat Park and Rack renewals, and purchases of Ramp Keys can still all be done by mail. But be on the lookout for a CAGID announcement, plan accordingly, get your necessary documents in hand, and respond as promptly as you can when you receive your renewal invoices.

NOTE WELL: One of the changes to the Calendar Year 2022 Schedule of Fees are increased Late Fees:

Slip fee and documentation not received by March 1: \$100 late fee

Slip fee and documentation not received by April 1: \$200 late fee

Slip fee and documentation not received by May 1: Loss of slip

Boat Park

Offers have gone out to those on the Wait List to fill the few remaining spots available.

Parking Scheme:

- Large, two-axle trailers will continue angled parking on the left (South) side of the lot, but not in the rear of the lot, *unless they will remain empty, i.e., no boats.*
- The rear of the Boat Park will be primarily for small, single-axle trailers/boats, and empty trailers.
- The right (North) side and the front of the lot will continue with angled parking for small, single axle trailers, and overflow of larger, two-axle trailers toward the center of the right side, along the fenced area.

It is critically important to park your trailers and boats as close together as possible so we can maximize the use of space in the Boat Park. Trailers may need to be repositioned to achieve best space utilization. If your trailer has a lock, please make sure that we have a copy of the key or lock combination.
